 Upon determination of the 4 teams, they will be seeded 1 thru 4 based upon overall record and the USSSA tie breakers

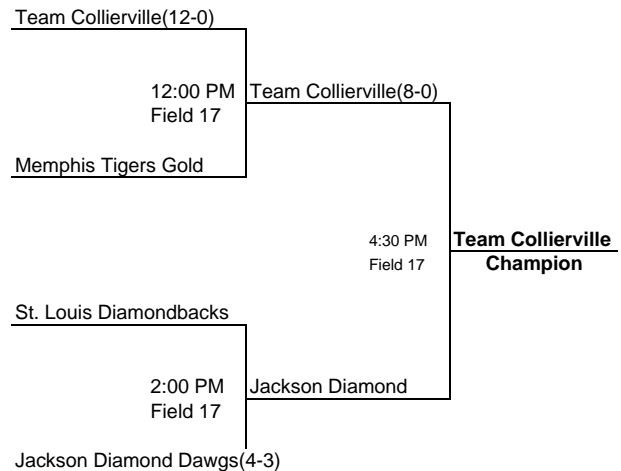
